Change in Benchmark of Open Ended Debt Schemes of Canara Robeco Mutual Fund (CRMF):

Pursuant to the provisions of Para 1.9 of SEBI Master Circular for Mutual Funds dated May 19, 2023 on "Guiding Principles for bringing uniformity in Benchmarks of Mutual Fund Schemes" and communication dated March 31, 2022, received from AMFI regarding First Tier Benchmark for open ended debt schemes as per the Potential Risk Class (PRC) Matrix, Canara Robeco Mutual Fund (CRMF) had implemented the benchmark change for open ended debt schemes with effect from April 01, 2022.

Further in this matter, SEBI vide letter dated December 14, 2023, advised AMFI to prescribe the Tier-1 benchmarks to be followed by the debt oriented active mutual fund schemes, to bring further uniformity in benchmarking of mutual fund schemes. Therefore, AMFI through email dated February 13, 2024 prescribed the list of PRC matrix-based Tier-1 Benchmarks for Debt Oriented Mutual Fund schemes.

Accordingly, Canara Robeco Mutual Fund has decided to change the First Tier Benchmark of open ended debt schemes with effect from March 11. 2024 as follows:
